Applications are invited from the eligible local candidates for filling up **20 (twenty) posts of General Duty Medical Officer (Junior Grade) on temporary regular basis in the Level 15 of the Pay Matrix** in the Sikkim State Health Service under Health & Family Welfare Department, Government of Sikkim, through **Direct Recruitment**. All applications are invited through online mode only at www.spscsm.gov.in

The application of roster points for category-based reservation has been relaxed vide Notification no. 35/GEN/DOP dated: 30.06.2021.

1. Minimum Educational Qualification:

1. Bachelor of Medicine & Bachelor of Surgery degree from a recognized university, AND
2. Should have completed rotatory internship of one year from a recognized institute AND
3. Registered with Medical Council of India or Medical Council of any State.

2. Age Limit:

Should have attained the age of 21 years , but should not have exceeded 50 years as on 30.06.2021 , in terms of Notification No: 154/GEN/DOP, dated: 05.12.2018.

3. Other Qualifications:


(a)	<i>Should have knowledge of any of the State Languages.</i>
(b)	<i>Should be conversant with the customs and usages of Sikkim.</i>

4. Required Documents:

(a)	Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government.		
(b)	Category Certificate issued by the competent authority of the Government of Sikkim.	(d)	Should have Valid Local Employment Card issued by the appropriate authority of the Government of Sikkim.
(c)	No Objection Certificate from the Head of Department in case of employed candidate.	(f)	Marital Status (for female candidate). In case of married women candidate, COI/SSC of Husband should be enclosed.

- 5. SCHEME OF EXAMINATION:** Recruitment to the above posts would be conducted through **selection by interview** as per rule 6 of the Sikkim State Health Service Rules, 1993.
6. Candidate should go through the advertisement and **read the instructions provided on the web page carefully before applying online. Applications received through any other mode will not be accepted and shall be summarily rejected.**
7. The candidates are advised to apply online from our website <http://spscsm.gov.in/> on or before **11.08.2021** up to 12 midnight. **Application submitted after 11.08.2021 will not be accepted by the software and SPSC will not be responsible for the same.**
8. **Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on 17.08.2021 and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC w.e.f. 18.08.2021 to 24.08.2021.**
9. Application fee amounting to Rs 150/- only may be paid online through credit/debit card, Net Banking by Visa/Mastercard. The amount once deposited shall not be refunded or adjusted against any other purpose.
10. e-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same will be published by the Commission in the official website of the Commission.

11. Eligible candidates would be called for the scrutiny of documents on dates as fixed by the Commission. Candidates would be required to submit attested Photocopies of all relevant documents.
12. No TA/DA is admissible for attending the Interview.
13. Admission to all the stages of examination for which candidates are admitted by the Commission will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without notice.
14. The Commission will entertain application on review or RTI/Correspondence only after the entire process of recruitment is complete.
