- **6.** Application fee amounting to Rs 150/- only may be paid online through credit/debit card, Net Banking by Visa/Mastercard. The amount once deposited shall not be refunded or adjusted against any other purpose. Candidates belonging to **PWD Category are exempted from paying the fees.**

- **8.** Candidates are directed to bring a Photo Identity proof like (Aadhar Card, Voters Card, Driving Licence) alongwith valid e-Admit cards in the examination centre for proof of identity.
