Applications are invited from eligible local candidates for filling up of 32 (thirty two) posts of Sub-Inspector on temporary regular basis in PB-2 of Rs. 9300-34800 plus grade pay of Rs.3800/- in Sikkim Police and Armed Police/IRBn, Government of Sikkim.

**ELIGIBILITY CONDITIONS FOR APPEARING IN THE EXAMINATION FOR THE POST OF SUB-INSPECTOR IN SIKKIM POLICE:**
